



Boy Scouts of America Troop 230 Flags Across America Commitment Form

Thank you for your commitment to help the troop earn money. Flags across America is the main fund raiser for our troop and allows the troop to participate in many worthwhile activities. By signing the commitment form on April 17 201__ , the scout (referenced as “you” below) and parent(s) agree to:

1. Post and remove the flags for each customer on the following 6 holidays: President’s Day, Memorial Day, Flag Day, Independence Day, Labor Day and Veteran’s Day
2. If you are unable to post the flags on a holiday, it is your responsibility to find a fellow scout to cover your route.
3. If a fellow scout covers your route, it is your responsibility to fill out and turn in the reimbursement form notifying the Scout Flag Scribe- to transfer the funds from your account to your fellow scout. (form can be found on the troop 230 website)
4. You must keep a personal spread sheet of your customers. A copy must be turned in each February with the customer information. **Your scout account will not be credited without the spread sheet.** The spread sheet must include: Scout name, Customer name, Customer address, Customer email, Check number and Amount. MS-Excel Template File is located on Troop website.
5. Completed form for each customer, detach the receipt at the bottom of the form so that your customers know how to contact you with any questions or concerns
6. Any check amount different than \$30 must include an explanation (for example flag is pro-rated, multiple flags, or a donation to scout)
7. Any insufficient fund or returned check is the responsibility of the scout to reconcile.
8. All flag renewals will be President’s Day each year. Money will be collected at a set meeting in February each year.

To simplify our data base the committee has decided:

- All flags will renew in February each year – President's day.
- Once your account aligns up to Feb renewal cycle, a specific meeting will be scheduled to collect checks and forms.

Since flags currently renew throughout the year, please collect a pro-rated amount for current year and complete following year. Tell your customer this is being done to ensure the Troop Administration is streamlined.

What does this mean? How much should I collect?

“Pro-rated amount” is based on the day you put up the first flag. “Following year” consists of 6 holidays that aligns up to Feb of next year.
